## The Trianon Dictate is Still in Effect. How Long can it Last?

The Freemasons used the destructive effects of the Pan-Slav movement in the Carpathian Basin in the interests of their dark, subversive goals. It is well worth looking at a map that appeared in 1890, in the Christmas edition of the English journal, *The Truth*, edited by a high-ranking freemason, Henry Labouchers. This journal was preserved in the museum of the Collingdale library and in it can be seen a map of the future states of Europe. Germany, Poland, Switzerland, Austria, Spain and Russia appear as republics. We know that, at that time, Germany, Poland, Spain and Austria were all monarchies. Hungary was not even mentioned because the dismemberment of Hungary had already been decided.<sup>1</sup>

According to this map, Rumania received the greater part of Hungary, Transylvania and the territory around the River Kőrös. Ödön Málnásy writes: „When Wilson arrived at the Peace Conference from America, all he knew about the peoples of Europe were the names of the Foreign Office and the Quay d’Orsay. However, when he left Europe, he complained that everybody lied to him.”<sup>2</sup>

On June 4, 1920, in the Trianon palace at Versailles, the so-called „Peace Treaty” of World War I was signed, which, since that time, the enlightened intelligentsia of the world has recorded as a „Peace Dictate”, and which is perhaps the most unjust dictate in the history of the world! Moreover, at the peace negotiations, the Hungarian delegation was not permitted to submit proofs in their defense, which is a fundamental condition of any treaty. During the process of negotiation, the representative of the Hungarian government, Count Albert Apponyi, was isolated under house-arrest and therefore rendered powerless. All they allowed the aging count was a short walk for his health and the opportunity to make a short speech. They instructed him to accept the decision and to validate it with his signature, which of course Count Apponyi and the entire Hungarian delegation refused. The ratification of the Dictate took place in the Trianon palace although nobody accepted the responsibility of placing his own signature on this death warrant. The situation forced them to decide to draw lots to choose the names of the signatories. Therefore the „chosen” people had to accept the misfortune of carrying out the decision. The

Hungarian signatories lived the rest of their lives as outcasts among the Hungarian people. One of them committed suicide some years later.

*Hungary, after the Monarchy lost the war, not only lost her king but two-thirds of her territory and population as a result of the thorough work of the international freemasons, who gave an indefensible reason for the establishment of the Hungarian Soviet Republic. In this, the role of the Jews was, so to speak, absolute. . .*

*The machinations of the international Freemasonry in the outbreak of the First World War and, later the so-called Dictated Peace-Treaties are well-known. There were no discussions. The result of this was that the new governments of the states on the losing side – among them the Hungarian government too -- were prevented from working. It appears that this did not disturb the functioning of the governments for several years. Since the lodges of the Freemasons did not do their work as open organizations, it is really not possible to know who the members were. The Hungarian Jews, as if nothing had happened, continued to infiltrate the offices of the government.*

*The rehabilitation of the wartime economy sooner or later necessitated the curbing of the inflation of the “korona” monetary system, and its complete liquidation. The Hungarian government put in place the necessary measures for this in due course. Recognizing the contemporary economic conditions, this was not possible without accepting credit from foreign sources. Let us not forget that the reconstruction and rehabilitation of the economy of mutilated Hungary was a greater responsibility for the Hungarian government than the reconstruction of the country after the Second World War. Both Prime Minister István Bethlen and Regent Miklós Horthy agreed that they would need credit. They began negotiations with the Swiss banks. The negotiations, with respect to their mutual interests, were conducted in a normal fashion and then they came to an agreement. Then, suddenly, the Hungarian government received a surprise and not a small one either. The last nonnegotiable condition of the lending banks was the permission for the banned lodges of the Freemasons to be reopened.*

*Horthy and Bethlen resisted for a while. At that, a powerful international Freemasonry offensive began to work over the leaders of the Hungarian government. Dr. Zoltán Török, an engineer, one of the leaders of the Hungarian Symbolic Great Lodge that was working secretly in Hungary, took upon himself the role of mediator. At the end of 1923, leaders of the Freemasonry organization, called the Association Maconnique Internationale, were brought together with Count István Bethlen to discuss the matter of the emancipation of the Hungarian lodges. Then, at the invitation of Dr. Török, the grand masters of the Swiss Reverchon and the New York Ossian Lang Freemason lodges traveled to Budapest. After long negotiations, they submitted a petition to the Regent to reopen the lodges.*

*The constant struggle finally ended. The Regent and the Government were forced to concede. We might say that a compromise was reached. The Hungarian government – now no longer tolerating opportunism – stipulated: the lodges of the Freemasons might operate but only as public bodies. Therefore they continued their secret operations under assumed names, for example: Free Milk Association, Free Bread Association, Home for Handicapped Children, Pesti Lloyd Society, Hungarian Cobden Association, Rotary Club etc. These associations were founded exclusively by former Jewish Freemasons.*

*Naturally, the Jewish role in these organizations was no secret to the members of the Hungarian government but they handled it graciously, in other words they „tolerated” it.*

*Horthy and his government soon forgot the transgressions of the Jews in the Soviet Republic of Hungary. There were no reprisals. There is no proof but we believe that Horthy’s creditors forbade him from doing so. It is also unexplainable how Horthy’s liberating counter-revolution made it possible for the defeated commissars to travel on luxurious trains, through Austria to Moscow, and take with them Hungarian assets valued at 200 million gold crowns. Horthy and his government never made any claims against the Soviet government for these huge assets. All this clearly proves that Béla Kun and his people did not carry out their responsibilities exclusively at the command*

In 2015, during his third term as Prime Minister, Victor Orbán, amidst great celebrations, and without even asking the Hungarian people, accepted the Israeli proposal to hold the Maccabi Games in Budapest, in 2019. He offered 2.1 billion forints (more than 7 million dollars) in support of the above-mentioned sport games. The Hungarian people were not even given the opportunity to vote to express their opposition to these games.

In 1948, after more than 2000 years, with arguments based on the Bible, Israel took over the land of Palestine. Since that time, with continuous aid and diligent nation-building work, she has developed into a powerful, strong, industrial state equipped with atomic energy. Since her inception, she has never suffered the loss of territory, whereas the Hungarian nation lost more than two thirds of her thousand-year-old ancient territory as a result of the straight-jacket imposed at Trianon. Of the original population of 18,264,533, only 10,649,416 souls remained to her. She lost cities, mines, railway-lines, elementary and secondary schools, arable land and forests. In this study, it is not our goal to make an exact list of the losses, but rather to inform the reader of the sensitive nature of these losses, so that he might get an idea of the merciless dismemberment of the nation, and recognize that the calumnies, on which this action was based, were unjust lies and unfounded accusations.

Hungary never oppressed the minorities or the denominational systems of education in the Carpathian Basin, in the Country of the Holy Crown. She never intended that the small nations that fled to her territory and were welcomed by her, be assimilated in the forceful manner that the French, Spanish and English used to assimilate their own minorities. Education in the Country of the Holy Crown was always conducted in the language of the denominations, that is the language of the priests. This is why the Romanians, Slovaks, Serbs and Ruthenians of Sub-Carpathia were able to survive and, after Versailles, chose to become separate nations. As a result of the Trianon Dictate, the monarchy was discontinued and abolished from the weakened state of Hungary. The so-called democracy was established and imposed on the Hungarian people, under the guise of which the organization of the Maccabi Games in Budapest is intended to drag them deeper into the shadow of annihilation, like a helpless puppet, a little state directed by foreign interests.

What could be the reason that the rich, flourishing state of Israel does not want to organize this exclusive and racially isolated sport competition in her own homeland? The organization of the Maccabi Games in Budapest must lead the peoples of the

world to suspect, even be convinced that Hungary is designated to become a colony of Israel! Therefore, we are asking the help of all freedom-loving countries that value independence for themselves, to express solidarity with us and help us to avoid and prevent another dismemberment. This assumption of ours, which appears to be somewhat bold, is not a mentally deranged hallucination; in 1910, this plan was already formulated by the Jews:

„Brothers! Brethren! There is no piece of land in the whole world that we can more easily conquer than Galicia and Hungary. These two countries must be ours, because the conditions there are most favorable for us. You, Jewish brethren, must work with all your might to take these two countries into your possession...the donations are flowing into our coffers with unexpected abundance, with the goal that the lands of Galicia and Hungary will be taken out of the hands of the Galicians and Hungarians and will fall exclusively into the hands of the Jews.”

(Appeal of the Alliance Israelite Universelle, 1910)

After all this, it is to be desired that our government support the true Sport Olympic Games, planned for 2024, which is impartial and in which the nations compete against each other in a peaceful rivalry, to measure against each other their strengths and abilities, and for which Hungary bid with a good chance of winning. The government rejected the bid in order to replace the Olympic Games with this racial Jewish sport competition, which excludes all other races and religions.

If the Olympic Games were really to take place in Hungary in 2024, they would surely bring recognition to our nation, which our performance up to now clearly deserves. Instead, now with Hungarian money, we should promote the honor and glory of Israel?

In the course of the history of the Hungarian nation, there is no doubt that Hungary deserved the support of the peoples of Europe, when the nation was in a difficult situation. Already in 1241-42, she opposed the Mongol world power, which was directed against Europe, and defended the existence of the peoples of Europe. Again she opposed the Ottoman world power, defending Europe against the Turks for several centuries, (the Turkish occupation of Hungary alone lasted 150 years) with the result that the Hungarian population was decimated. But beyond all this, there is the certainty that demands recognition, that in the world of knowledge, in comparison to the size of her population, she contributed greatly to the culture and

civilization of Europe and the world. I write these lines, not looking for praise, but as a call for help... Please help before it is too late!
